

LIVING PEACEFULLY AT THE LAKE – HOW CAN WE MAKE IT HAPPEN?

Lloyd Weyland, President of the Saskatchewan Association of Bylaw Enforcement Officers, talked about his experience enforcing bylaws such as parking violations, abandoned vehicles, dog complaints, permits and licenses. The bylaw enforcement officer does not enforce speeding laws or the criminal code. Al Christensen and Jerry Aspvik described how the RM of Lakeland uses their bylaw enforcement officer to check out septic tanks, take complaints from cottage owners and hand out “door knocker: first-offense warnings”. Many delegates have asked for a follow-up workshop on this topic.

WATERFRONT CHALLENGES

Gill Happ from the Ministry of Environment talked about the crown foreshore (the beach) and the reserve land between the beach and lakefront property (from 1 meter to 30 meters wide). He spoke to common myths such as:

MYTH - You can own property up to the lake.

FACT - Beach and reserve lands belong to the crown.

MYTH - You are entitled to a view of the lake.

FACT - You need a permit to remove trees and shrubs.

MYTH - You can keep people off the beach or your dock.

FACT - You don't own the beach; any dock must be available to the public during emergencies.

Inga Thorsteinson described Transportation Canada's mandate to regulate marinas, docks, boatlifts, swimming platforms – with regard to the safety of the boater. She reminded us about the 10-30 law (boaters cannot exceed 10 km/hr within 30 metres of the shoreline) and referred delegates www.tc.gc.ca/marinesafety to learn more about the Navigable Waters Protection Act and to access development permit applications.

DEALING WITH SEWAGE AT THE LAKE

Tom Kehoe, former chair of the Lac Pelletier Cottage Owners Association, described how their lakeshore communities wanted to move away from field spraying and how they went about soliciting the support of their rural municipality and working co-operatively to build a regional sewage lagoon. Ben Lichtenwald, Ministry of Environment, admitted that although many resort communities continue to field spray, the field spraying regulations are currently under review. He spoke to current guidelines stating that field spray:

- Should not be done on sandy soil or on snow,
- Should not be done on food crops,
- Must be at least 1 km from occupied dwelling, and
- Should be tilled within 4 days.



Shirley Gange refers delegate questions to Gill and Inga – including the frustration of the delegate who described how “we at the municipal level are continually frustrated by the gutless and toothless support from government administration.”
